An Exclusive Report for the OVNI from American 'FT' Author Bill Foster

In this issue of the OVNI, we are carrying an exclusive report from Bill Foster, the co-author of 'The Black Triangle Abduction'. Quoted as being a "bigger revelation than the Travis Walters story", this concerns the abduction of 'Michael' a fellow American and is carried on pages 5 to 7.

We are currently pursuing one of the big UFO 'artefact' mysteries that has recently come to light and that is the 'Bob White' story. At present the details of the incident leading up to the procurement of the artefact are sketchy and we are actively pursuing the story. (See page 8.)

There are a number of UK UFO reports and you will find these throughout this issue, the last-minute content is often changed to take the latest reports into account. There are for instance several colour photo's shown on page 3, that have been kindly sent to us by Ernie Sears of the SUFOG group. They remain something of a mystery and are presented to you for your own assessment.

It was intended to publish in full, an important article from the 'New Scientist' issue 2565 19 August 2006 referring to the evolution discussion taking place in the USA, but due to shortage of space, an edited version is given below:

Why doesn't America believe in evolution?

19 August 2006 From New Scientist Print Edition. By Jeff Hecht

Human beings, as we know them, developed from earlier species of animals: true or false? This simple question is splitting America apart, with a growing proportion thinking that we did not descend from an ancestral ape. A survey of 32 European countries, the US and Japan has revealed that only Turkey is less willing than the US to accept evolution as fact.

Religious fundamentalism, bitter partisan politics and poor science education have all contributed to this denial of evolution in the US, says Jon Miller of Michigan State University in East Lansing, who conducted the survey with his colleagues. "The US is the only country in which [the teaching of evolution] has been politicised," he says. "Republicans have clearly adopted this as one of their wedge issues. In most of the world, this is a non-issue."

Miller's report makes for grim reading for adherents of evolutionary theory. Even though the average American has more years of education than when Miller began his surveys 20 years ago, the percentage of people in the country who accept the idea of evolution has declined from 45 in 1985 to 40 in 2005 (*Science*, vol 313, p 765). That's despite a series of widely publicised advances in genetics, including genetic sequencing, which shows strong overlap of the human genome with those of chimpanzees and mice. "We don't seem to be going in the right direction," Miller says.

The main opposition to evolution comes from fundamentalist Christians, who are much more abundant in the US than in Europe. While Catholics, European Protestants and so-called mainstream US Protestants consider the biblical account of creation as a metaphor, fundamentalists take the Bible literally, leading them to believe that the Earth and humans were created only 6000 years ago.

How would these people respond when told that humans and chimps share 99 per cent of their genes?

UFO SIGHTINGS OVER LONG EATON, NOTTINGHAM

It was on Wednesday 23rd August 2006, at 9.03 pm and me and my friend looked out of the window because my friends son had told us he could see a UFO flickering in the sky, we have also seen this and it looked to be still. It was about five minutes later that he saw a "glowing cylinder" lighting up the clouds overhead.

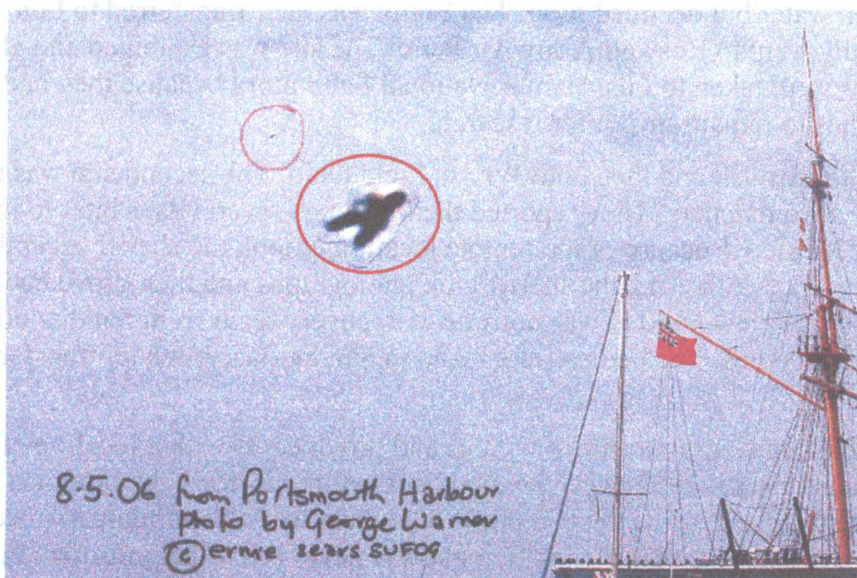

Ernie has sent us a selection of the many digital photographs taken by SUFOG member George Warner over the southern coast port and naval headquarters of Portsmouth.

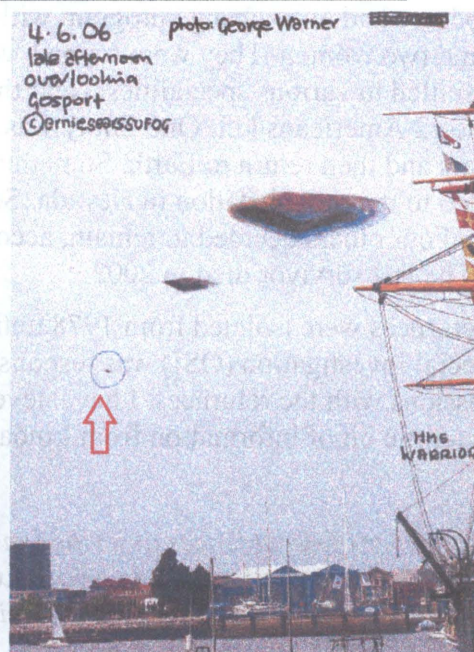

FACT OR FICTION?

My name is Sylvester McCoglin. I am a retired employee of the US Government. I won't go into any great details about my past but I was involved in a special program.

As for Roswell, it occurred, but not like the storybooks tell. There were two crash sites. One Southwest of Corona New Mexico and the second site at Pelona Peak, South of Datil New Mexico. The crash involved two Extraterrestrial aircraft. The Corona site was found a day later by an Archaeology Team. This team reported the crash site to the Lincoln County Sheriff's department. A deputy arrived the next day and summoned a state police officer. One live Entity was found hiding behind a rock.

The Entity was given water but declined food. The Entity was later transferred to Los Alamos. The information eventually went to Roswell Army Air Field. The site was examined and all evidence was removed. The bodies were taken to Los Alamos National Laboratory because they had a freezing system that allowed the bodies to remain frozen for research.

The craft was taken to Roswell and then onto Wright Field Ohio. The second site was not discovered until August 1949 by two ranchers. They reported their findings several days later to the sheriff of Catron County New Mexico. Because of the remote location, it took the sheriff several days to make his way to the crash site. Once at the site, the sheriff took photographs and then drove back to Datil. Sandia Army Base, Albuquerque New Mexico was notified. A recovery team from Sandia took custody of all evidence, including six bodies. The bodies were taken to Sandia Base but later transferred to Los Alamos.

The live Entity established communications with us and provided us with a location of his home planet. The Entity remained alive until 1952, when he died. But before his death, he provided us with a full explanation of the items found inside the two crafts. One item was a communication device. The Entity was allowed to make contact with his planet. Somehow, I never knew this information, but a meeting date was set for April 1964 near Alamogordo New Mexico. The Aliens landed and retrieved the bodies of their dead comrades. Information was exchanged. Communication was in English. The Aliens had a translation device.

In 1965, we had an exchange program with the Aliens. We carefully selected 12 military personnel. Ten men and two women. They were trained, vetted and carefully removed from the military system. The 12 were skilled in various specialities. Near the Northern part of the Nevada Test Site, the Aliens landed and the 12 Americans left. One Entity was left on Earth. The original plan was for our 12 people to stay 10 years and then return to Earth. Something went wrong. The 12 remained until 1978, when they were returned to the same location in Nevada. Seven men and one woman returned. Two died on the Alien's planet. Four others decided to remain, according to the returnees. Of the eight that returned, all have died. The last survivor died in 2002.

The returnees were isolated from 1978 until 1984 at various military installations. The Air Force Office of Special Investigation (OSI) was responsible for their security and safety. OSI also conducted debriefing sessions with the returnees. I have never seen or read anything about the exchange program. I once heard a little bit of information from Linda Howe but she didn't have much information.

THE STORY BEGINS....

A Report By Bill Foster (USA) Co-Author of 'The Black Triangle Abduction'.

You may not find this story compelling because at the moment, it only has a beginning. When the "middle" and the "end" of the story unfold, it may well be a bigger revelation than the Travis Walton story. That story, circulated like wildfire in the United States, after Travis Walton and his four friends spotted a UFO, low over a mountaintop. Travis Walton jumped out of the truck and was abducted for **seven days** by the grays!

This is the story of a man who was abducted for **three days**. The catch is that this man does not yet know the full extent of his own incredible story. Let's begin at the beginning.

My name is Bill Foster. I wrote a book in 2005 about the abduction of my wife, our two companions and myself back in the year 1996. It was called: "THE BLACK TRIANGLE ABDUCTION." As a result of extensive publicity upon release of my book Karen and Robert Tate interviewed me on a national television show. (I am not using real names in this text for anyone except myself, as I have not asked for permission to do so.)

One week after the television show was aired, Karen called me and asked me if I would mind speaking to a fellow in Montana named Michael Johnson. She said he had called her and seemed very distraught about some "unusual" experiences he was having. Karen remembered me discussing, during our one-hour television interview together, scoop marks on both my chins. She said that Michael has the same sort of marks and was upset about them. I told her I would be happy to talk to Michael.

Michael called that evening and we talked for over an hour. Indeed, he was very upset and as with most people, had no idea who to talk with that would earnestly listen to his concerns. (Most folks either laugh or think you are crazy if you accept UFO experiences as fact.) I reassured Michael that regardless of what he said, I would not laugh nor ridicule his thoughts.

Michael said he had been having strange dreams. In his dreams he was seeing distorted faces that did not look human. He saw strange bright lights outside his bedroom window on many evenings. He could not comprehend if he was awake or dreaming. Then, the scoop marks appeared on his legs. The morning he discovered the marks he decided that something **real** was going on, but he had no idea what it could be. Michael was not interested in UFO's or alien abduction. He was neither a science fiction fan nor a reader of books of that genre. Michael thought, perhaps, he was losing his mind.

I assured Michael that he was not crazy. His physical marks were real, not self-inflicted and further had probably resulted from contact with the "Grays". (The Grays are the most common form of alien contact promulgated in the United States. These creatures are about 4' to 4-1/2' tall with oversized heads, large eyes and gray, wrinkled skin, hence the nickname: "The Grays".) This information, of course, did not ease his mind.

I told Michael to do two things:

- (1) Contact the Area Director for the Mutual UFO Network (MUFON) in Montana and tell him about the experiences.
- (2) (Go to a regression therapist, get hypnotized, and bring back the events of the past year into clarity

I gave him the phone number for the Area Director of MUFON and I gave him the name and phone number of a hypnotherapist close to his home, that would be happy to work with him. Michael seemed concerned over the cost of this process.

I assure Michael that talking to MUFON costs nothing and the hypnotherapist could treat him for "stress", "disassociation" and even post traumatic stress syndrome, the symptoms of which are treatable and would all be covered by insurance, (which he had), as a mental impairment. Michael assured me he would do that.

One week later Michael called me back; there was terror in his voice. I could sense the strain in his voice as he chose his words carefully to me. Something new had happened, something bizarre and ominous. He had been seeing faces in the night. Ugly, distorted, "lizard-looking things", as he said, which terrified him.

(Now it sounded to me as though his encounters were **not with grays**, but with a breed some abductees call: "The Reptilians". These are an aggressive lot who are very rough on humans, so I am told. I did not share this information with Michael, it would only have added to his unstable condition.)

I asked Michael if he had called MUFON or contacted the therapist I recommended, he had not. Once again, I urged him to talk with them. I said:

"Michael, I am not a therapist, I am not a doctor, I am not even an investigator of this phenomenon, and all I am is a guy, like you, who has had some experiences. I can't help you – they **can help you!**" He assured me he would hang up the phone and call them immediately. The story ends here for three months.

It is 7:30 p.m. on a Sunday evening. My wife and I are home visiting with our daughter and our three granddaughters. The phone rings and I answer. The

voice on the other end of the line asks if I am Bill Foster. I tell the caller that I am indeed one in the same. The caller speaks very broken English and he is very hard to understand. He asks if I know James Johnson. I pause to think. The name does not ring a bell in my mind. I ask again who he is. He tells me his name is Carlos and he is James' Uncle. He apologizes for his English and tells me he is from Yugoslavia. He tells me he found my name in James' apartment with my telephone number underneath and the words: "UFO" written beside my name. Now it dawns on me!

"Do you mean **Michael Johnson?**" I asked him, hesitantly. "Oh yes.", he replied, "James often used just his middle name with friends. His full name is James Michael Johnson." Now I remembered...

Carlos sputtered out his concerns:

"James is in a mental institution. He disappeared for three days and was found wandering around the edge of town last night, in his pajamas. The sheriff who found him asked him what had happened and he just kept saying 'they took me – they took me'. The sheriff thinks he is crazy so he takes him to the psychiatric hospital and they committed him for the next 30 days. Both of James parents think he is crazy too so they will not talk to him. I am the only person who believes James and I thought perhaps you could help me."

At hearing this revelation, I immediately told Carlos that I would have to go upstairs so we could have a private conversation in my office without the background noise level of our three grandchildren bothering us. I picked up the phone in my office.

"Carlos, can you hear me? Good. Now, what makes you believe James when everyone else thinks he is crazy? Why don't you think he is crazy too?"

"Well Bill, James and I have had some 'experiences' together when I have stayed at his apartment, visiting him. You see, I am in the mining business and I travel all over the world. In fact, I have to go out of town tomorrow and I just hate to leave James in there without anyone to talk to. I will tell you just one experience we had together, it happened three days ago. I was staying with James. We got up in the morning, glanced at the ceiling in the front room and both said: 'What in the world is that?' It was a thick mucous-looking gray-white substance covering about a foot around on the ceiling. Strands of this stuff were hanging down and it looked wet and a little like human skin! We took a broom and scrubbed it off the ceiling and got the spot cleaned up. It was very weird. I have seen many things

the night at James apartment and they were strange. If James tells me he was 'taken' by someone or something, I believe him. I know for a fact he was gone for three days because I stayed at his apartment until he was found by the sheriff."

I told the Uncle to immediately call MUFON, same phone number I had given James three months before. I assured Carlos that I would contact some folks and call him back. He told me I could not call him, as he was leaving the country in about 10 hours. I asked him for a cell phone number, he refused. I asked him for his local number, he refused. I asked him for an email address. He said he 'shared' an email address with James and gave me that email address. Carlos had one further revelation to tell me.

"You know Bill, something really bothers me. I went to the hospital and was told I could not see James for first 48 hours of incarceration. (NOTE: This is commonplace in all psychiatric hospitals in the United States.) I watched a big, black, SUV drive up with government plates on it and two men in black suits got out. I followed them to the desk and these two men asked for James Michael Johnson's room number. They flashed some badges and were admitted at once. I was able to call James on the phone sometime after that and he said the two men were indeed from the government and showed him two triangular badges with holograms on them and four black lines running diagonally, across the badges. They questioned James for over an hour about his 'experience' and then left. James still sounded very afraid. Bill, why would the government of this country want to talk to James?" (Well, my dear reader, you and I know the answer to that question, don't we?)

The uncle went on to say further that when he went back to James apartment to get James some clothing and toilet articles the apartment was **padlocked!** He could not get in and the landlord would not speak to Carlos about the situation.

I hung up with Carlos by reassuring him I would send him an e-mail as soon as I got more information.

I told my wife the gist of the conversation and she checked our phone for caller I.D., the caller's number was **blocked!** Carlos would not give me a phone number, a cell phone number and now the number he called from was blocked? How do we know this fellow was really James' Uncle?

I immediately called Karen back at the television station and relayed the story to her. She verified that Carlos was indeed the Uncle of James. How did she know? It seems that Carlos, not James, had contacted her in the first place. The Uncle had seen the television show and wanted James to talk with someone so he asked her if she would talk to James. She did and then got me to talk with Michael, as I knew him to be named.

Now I know what you are thinking. Why am I not worried that the government men would track me down? Those same government agents obviously locked up James apartment and could easily trace me as the uncle did from the note on the scratch pad with my phone number. The reason for my lack of concern is the single word - publicity.

I am not famous but I am a published author on the subject. The government knows that if I were "visited" and questioned about this situation I would **immediately call** the television station and give them all the details. Karen would just as quickly put all that information out over the airwaves. The government wants silence on the subject, not publicity!

As I told you at the outset this is only the beginning of the story, the middle and the end are yet to evolve.

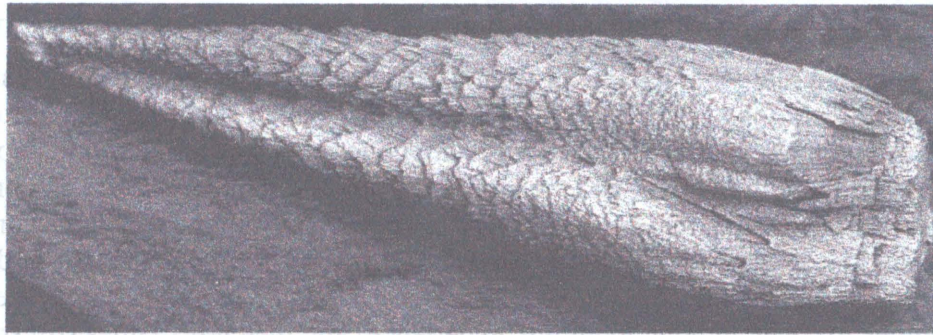
Karen and I are both working with special "contacts" in the UFO field here in the United States to:

This is not the end of the story; it is, however, the end of the beginning.

THE 'BOB WHITE' STORY?

"We are dealing with the biggest story of the Millennium": Stanton Friedman

from Bob White's UFO encounter in 1985.

This may be a piece of extraterrestrial metal! It is mostly aluminium with weird properties !

Apparently in 1985, Bob White had a close encounter with a UFO, in the form of a craft that was in difficulties and emitting globules of molten metal. This apparently took place just off a desert road somewhere in the United States.

From the information that we have received so far, it is understood that Bob retrieved a piece of the melted metal and has since had it analysed by two well known testing authorities. Details follow:

"The material was tested by The National Institute For Discovery Science and a facility at Los Alamos".

A sample was cut off by the NIDS and Bob himself finally succeeded in cutting off a sample after 2 1/2 hours working with a hacksaw, during which time he broke one blade and ruined the teeth on two other blades.

Witness Report:

I was travelling North on Highway 65 when I noticed a very large triangular shaped craft and a smaller craft which crossed over the interstate travelling around 50 mph. The larger craft had 3 small dim lights at each end of the triangular shape and a larger red light on one side. The smaller craft had many lights and looked more like a helicopter. By the time I had reached the part of the interstate where they had crossed, they were over the trees heading southeast. I stopped my car on the side of the road, got out, and continued to watch these two craft continue to travel very slowly. I heard no noise at all from these two craft. I got back in my car and continued to travel North. About 5 minutes later I saw about 6 military helicopters cross the interstate in the opposite direction. I knew they were helicopters by the very loud sound their blades made. This all happened about 20 or 30 miles south of Montgomery, AL at 9:15 pm.

Signs of Horrific New Solar Cycle to Begin

On July 31st, a small sunspot was viewed and recorded. This finding which shows the first sunspot in 'magnetic reverse', suggest the ushering in of a new solar cycle. This one would be "Cycle 24". Solar physicists have known that sunspot magnetic fields reverse polarity from cycle to cycle. North becomes South and South becomes North.

David Hathaway, a solar physicist at the Marshall Space Flight in Huntsville, Alabama states "A backward sunspot is a sign that the next solar cycle is beginning." The term 'backwards' as used by Hathaway means the magnetic lay-lines of a sunspot(s) have reversed.

As heard "live" on the ECM/ECTV "Radio Hour", Dr. Mausumi Dikpati research scientist at the National Center for Atmospheric Research in Boulder, Colorado disclosed for the first time on national and international air-waves, "Cycle 24 will be up to 50% stronger than the current cycle (Cycle 23)". Cycle 23 delivered the largest solar flare 'ever recorded'. The November 4th 2003 solar flare was estimated to be an X-45. Up until this time, all measuring instruments stopped at X-9.

Earliest references to a possible stash of records beneath the Sphinx

Our search begins with several stone stelae or tablets from the Middle and New Kingdom periods (between 4,000 and 3,000 years old), found in the vicinity of the Sphinx, which show the great animal reclining on top of a high pedestal surmounted by a cornice. One ancient artist, a Twelfth Dynasty scribe named Mentu-her, made sure his viewers knew his subject matter was the Great Sphinx and not other sphinxes found along the Nile, by drawing in the Pyramids in perspective in the background, a technique very rarely seen in Egyptian art.

Seven other stelae go further, and show a door on the side of the pedestal. The famous Stele of Thutmose IV, located between the paws of the Sphinx, likewise depicts at its top the Sphinx lying upon an understructure, with a doorway clearly seen. Finally, on yet another stele, made by an official named Nezem, and now kept in the Louvre, there is clearly depicted a flight of six steps leading to the door.

An important early Egyptian source that tells us much about the Hall of Records is called the Building Texts, found among the hieroglyph inscriptions on the inner enclosure wall of the temple of Horus at Edfu, in the heart of southern Egypt. The Building Texts refer to a number of now lost documents, grouped together into what was called The Sacred Book of Temples, which gave a history and description of the major shrines along the Nile from a very remote period. These were first established by a group of creator-entities called the Shebtiw, who were associated with the god Divine Heart or Thoth, the Egyptian deity of Wisdom.

According to the Building Texts, the sacred books and **power objects** were eventually placed back inside the bw-hmn or Hall, and the Shebtiw sealed the entrance, constructed a new enclosure about it, and erected power staffs and pillars outside to protect its secrets, hidden away again from all but its guardians. The site thereafter became known as bw-hmr, the Place of the Throne of the Soul, regarded as the location where only the highest Initiations were performed.

In another Egyptian text, known today as the Westcar Papyrus, which bears evidence of dating to the Fourth Dynasty, is the story of an enigmatic sage named Djeda who could not only perform miraculous feats of magic, but who also possessed certain information concerning what he called the secret chambers of the books of Thoth. In the narrative, Djeda told Pharaoh Khufu the location of specific keys that will one day open the hidden place, which he described as follows: In the city of Ani (Heliopolis) is a temple called the House of Sapti, referring to Septi, the fifth Pharaoh of the First Dynasty, who reigned about 3000 B.C. Within the temple is a special library room where the scrolls of inventory are kept. The walls of this room are made of sandstone blocks, and either within or behind one of these blocks is a secret niche containing a small box made of flint or whetstone. It is within this box that the ipwt-seals or keys that will open the secret chambers of Thoth, the Hall of Records, may still be hidden.

Today, many portions of the old city of Heliopolis are still buried and unexcavated, silently resting underneath the expanding suburbs of Cairo. The secret of the House of Septi may yet await discovery.

Interpreter of ancient languages Zecharia Sitchin cites a hymn composed in the Eighteenth Dynasty which speaks of the god Amun taking on the functions of the heavenly Harakhty (the Sphinx) who attains perception in his heart, command on his lips as he enters the two caverns which are under his (the Sphinx's) feet. The command of Amun is then placed into the writings of Thoth, the god of Hidden Knowledge and Initiation.

The famed Greek historian Herodotus, in 443 B.C., recorded after his visit to Egypt that extending beneath and in all directions far beyond the pyramid whereon great figures are graven is a vast labyrinth, and a way into it underground.

NEW ZEALAND UFO NEWS

A Report From - Sue Hansen, UFOCUS NZ Network. Investigator – B. Humphries.

Date: Sunday 21 May 2006 **Time:** 5-6.30 am

Duration of sighting: Approx. 1 hour

Place: Rimutaka Ranges, Wairarapa, North Island, New Zealand

Description:

The sighting took place when the witness and his companion were travelling to Lake Wairarapa early Sunday morning to go duck shooting. The reporting witness has over 30 years experience hunting and tramping in the Rimutaka Ranges.

The companions travelled out through Upper Hutt, over the Rimutaka Ranges, and then proceeded through Featherston into the Martinborough area. Their final destination was to be a 'maimai' (camouflaged duck shooting shelter) located near Kahutara, Lake Wairarapa.

It was early morning; the conditions were clear at the time, with no wind or moon.

The witnesses first spotted the unusual light between 5 and 5.30 am, when driving through Kaitoke, north of Upper Hutt on the approach to the Rimutaka Ranges. It was directly ahead of them over the hills; a large, bright purple/blue light, which changed to yellow and then white. The light initially appeared to be oval in shape, but its shape then became distorted or fuzzy. As the witnesses drew closer to the hills, the light moved and suddenly appeared very close to them, almost over them at one stage, before returning back to its original position at approximately 30-35 degrees above the ranges. They noticed that there was no sound accompanying the movement of the light close to them. The witnesses described the light as having soft hues that appeared to glow. They described the size of the light as 'substantial'.

The light remained in view for approximately another 20-25 minutes until the men drove over the ranges and down the other side towards Featherstone. At this stage they lost sight of the light because of the close proximity of hill ridgelines. The men continued on their way discussing what they had seen. (The reporting witness had observed a similar unusual light on the West Coast of the South Island many years ago).

Upon arriving at the maimai, located at the north eastern end of Lake Wairarapa, the men busied themselves preparing for the mornings shooting. Once settled in the maimai, the witnesses were facing in a southwesterly direction overlooking the lake, waiting for ducks to show up! The sun had not yet risen.

Shortly after 6 pm, the men noticed a glow behind a hill called Maunganui, some 12 kms distant (an estimate). Near the hill was a flat plateau along Western Lake Road. The witnesses observed this whole area - and the surrounding hills also - light up as if in daylight, and they saw a glowing light visible above Maunganui. This brilliant expanse of light remained constant for approx. 10 minutes before suddenly extinguishing, leaving the area in semi-darkness again before sunrise. The area that was lit up is sparsely populated, with only a few farms in the area. Both men were left baffled by this strange spectacle.

Hybrid mutant beast's body found- More mystery creatures

An evil looking thing: The animal was found dead after being struck by a car while chasing a cat in Turner, Maine

An animal found dead in the United States may be the mysterious creature that has mauled dogs, frightened residents and been the subject of local legend for half a generation.

The animal was found near power lines along Route 4 near Turner, Maine, on Saturday. It had apparently been struck by a car while chasing a cat.

The carcass was photographed and inspected by several people who live in the area, but nobody is sure exactly what it is.

Michelle O'Donnell of Turner, Maine, spotted the animal near her yard about a week before it was killed. She called it a "hybrid mutant of something".

"It was evil, evil looking. And it had a horrible stench I will never forget," she told the Sun Journal of Lewiston. "We locked eyes for a few seconds and then it took off. I've lived in Maine my whole life and I've never seen anything like it."

For the past 15 years, residents across Androscoggin County have reported seeing and hearing a mysterious animal with chilling monstrous cries and eyes that glow in the night. The animal has been blamed for attacking and killing a Doberman pinscher and a Rottweiler the past couple of years.

People from Litchfield, Sabattus, Greene, Turner, Lewiston and Auburn have come forward to speak of a mystery monster that roams the woods. Nobody knows for sure what it is, and theories have ranged from a hyena or dingo to a fisher or coydog, an offspring of a coyote and a wild dog.

Now, people are asking if the mystery beast and the animal killed over the weekend are one and the same.

Wildlife officials and animal control officers declined to go to Turner to examine the remains. By Tuesday, the carcass had been picked clean by vultures and there was not much left of the dead animal.

Loren Coleman, a Portland author and cryptozoologist, said it's unlikely that the animal was anybody's pet.

After reviewing photos of the carcass, Coleman said he was bothered by the animal's ears and snout. It reminded him of a case years ago in northern Maine in which an animal shot by a hunter could not be identified. In the end, wildlife officials got a DNA analysis that showed the animal was a rare wolf-dog hybrid, he said.

Mike O'Donnell, who is married to Michelle O'Donnell, said the animal looked "half-rodent, half-dog" to him.

It was charcoal gray, weighed between 40 and 50 pounds and had a bushy tail, a short snout, short ears and curled fangs hanging over its lips, he said. It looked like "something out of a Stephen King story".

"This is something I've never seen before. It's an evil-looking thing," he said.

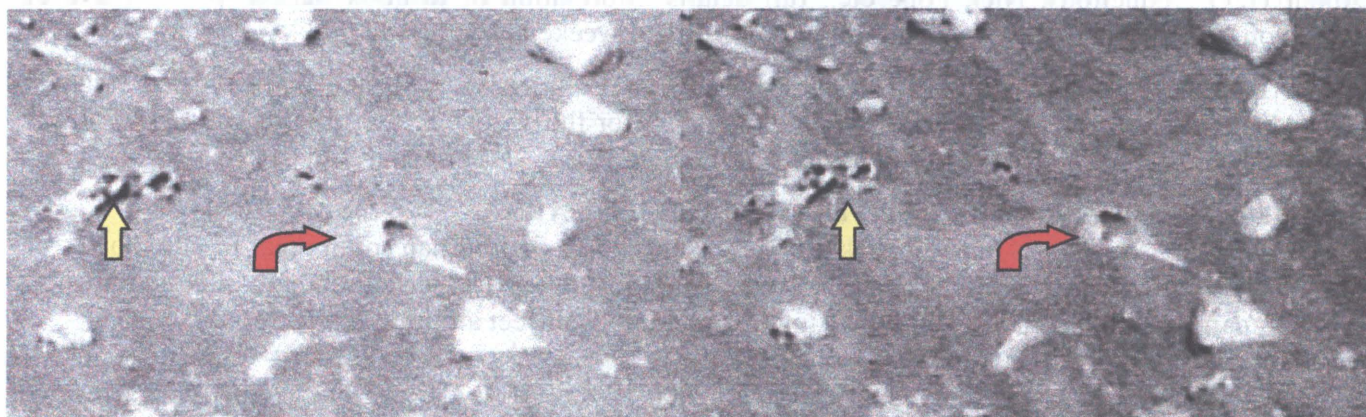

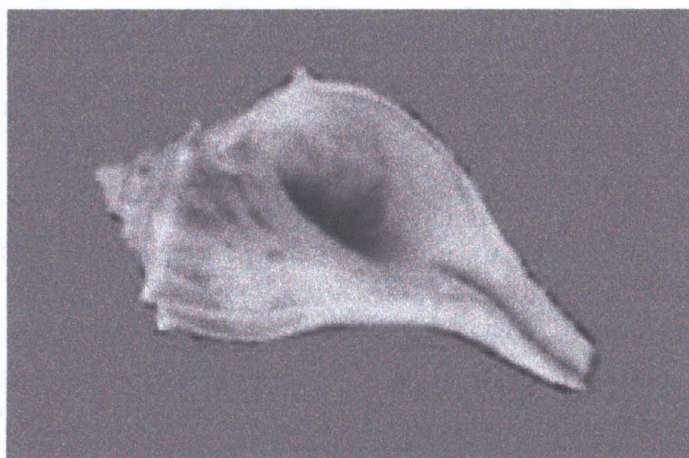

Mars Sea Shell Found Sir Charles W. Shults III, K. B. B. *Xenotech Research reports*, "I have new findings of perfect 3 D pictures of sea shells from the Mars Rover Spirit on Sol 913 at the wintering grounds where NASA has parked the rover.

The angled hillside provides best sunlight for the solar panels and allows the rover to continue operating well into its second year. These new images show some excellent specimens that are without a doubt some of the clearest sea shells yet imaged on Mars.



I have cropped out the sea shells and combined them in individual, stereo views. The first is a broken open spiral shell and presents its spiral end directly to us. You can see that it is perfectly round, wafer thin, and does indeed spiral at the tip. This second one is another species but identical to many terrestrial sea shells. It is on its side and broken open.



The above image is a terrestrial whelk shell found on a beach. Now compare these side by side.

The similarity is unmistakable. This is clearly another Martian sea shell. *A second sea shell in the same image frame. This is very clear; no other item has this look or structure.*
